The New Introduction is neither a revision of McKerrow nor McKerrow brought up to date. It is a new and different book, going a long way beyond its predecessor in point of time since it includes a general survey of the machine-press period up to 1950, whereas McKerrow had stopped at 1800. Philip Gaskell's *A New Introduction to Bibliography* (usually shorthanded as simply "Gaskell") provides a good introduction to the transmission of texts, from the hand-press period through the middle Read full review. However, in recent years, there has been an increasing interest in the textual problems of the 18th, 19th and 20th centuries, and, although McKerrow covered the period up to 1800, he did not describe the technology of the machine-press period.
